Memorandum of Understanding between Concordia University Wisconsin & Ann Arbor and University of Detroit Mercy

I. INTRODUCTION

Concordia University Wisconsin & Ann Arbor (CUWAA), an institution of higher education accredited by the Higher Learning Commission (HLC), and University of Detroit Mercy (UDM), an institution of higher education also accredited by the Higher Learning commission (HLC), have entered into this Memorandum of Understanding (MOU) as of the date of the last signature below.

Concordia University Wisconsin & Ann Arbor will cease offering some programs in a face-to-face format on the Ann Arbor campus at the end of the spring 2025 semester, Sunday, May 4, 2025. The purpose of this MOU is to ensure the equitable treatment of students enrolled in programs on the Ann Arbor campus and to ensure a reasonable opportunity for such students to complete their program of study at UDM. UDM will offer automatic admission to CUWAA Teach Out students into its Teach Out Programs for the Ann Arbor campus students who are eligible as defined below.

II. Participation Eligibility

Any student actively enrolled (this includes students who are actively enrolled, but officially on leave) at Concordia University Ann Arbor campus in the spring of 2025 or fall of 2024 semester ("Teach Out Student(s)") shall be a beneficiary of this MOU by enrolling in a program agreed upon by CUWAA and UDM as listed in Exhibit A. CUWAA students who wish to participate in the teach out at UDM must participate in the CUWAA comparable program designated by UDM in Exhibit A. Students who wish to attend UDM under a different major/program than that of their CUWAA major/program are not eligible for the same Teach Out benefits and will be considered transfer students by UDM.

III. University of Detroit Mercy Responsibilities

- All student credits from the CUWAA Liberal Arts undergraduate core curriculum will
 count toward completion of undergraduate degrees and will replace equivalent credit
 requirements of Detroit Mercy's undergraduate core curriculum. All Teach Out Student
 credits will be accepted toward an equal or comparable degree program at University of
 Detroit Mercy, as outlined in Exhibit A.
- 2. UDM guarantees admission without application fees to all CUWAA Teach Out Students.
- 3. The pathway to graduation for each CUWAA qualified Teach Out Student to UDM will allow Teach Out Students to complete their program in the same timeframe as was possible at CUWAA (or sooner).
- 4. UDM will waive its residency requirements (requirement that a certain number of credit hours must be earned at UDM to earn a degree from UDM) for all Teach Out Students under the terms of this MOU.
- 5. All CUWAA completed credit hours for the Teach Out Students will be applied to the appropriate UDM program as detailed in Exhibit A. UDM will transfer in credits from other accredited institutions that were already transferred to CUWAA as part of the students' transcript. Official copies of transcripts from other institutions attended are required.
- 6. UDM will designate two specific points of contact, Lynn Vitale, Director of Transfer & Graduate Admissions, (313) 993-1147, vitalel@udmercy.edu and Chris Keys, Senior Admissions Counselor, (313) 993-3289, keyscl@udmercy.edu, to assist Teach Out Students in answering questions regarding the specific terms of this MOU, including without limitation the charges described in Exhibit B.
- 7. UDM will provide Teach Out Students with academic advising by its professional advising staff and/or full-time faculty, as appropriate.
- 8. UDM will provide the same level of ADA accommodations for Teach Out Students as received from CUWAA. Students or the Academic Resource Center & Accessibility Services of the Ann Arbor campus must provide accommodation letters and documentation to UDM's Office of Equal Opportunity. - UDM will provide Teach Out Students with financial aid counseling provided by admission and/or financial aid staff. Teach Out Students will be eligible for grants and/or scholarships as outlined in Exhibit B.

- 10. Teach Out Students will be eligible for available on-campus housing through UDM at rates outlined in Exhibit B.
- 11. UDM will maintain a record of all student Grade Point Equivalencies for their tenure at UDM and will provide documentation for any future graduate application or transfer of credits.

IV. Teach Out Student Admission Process

- 1. Complete the UDM online enrollment form at www.udmercy.edu/apply. No application fee will be assessed for CUWAA students applying to UDM.
- Submit official CUWAA transcripts to UDM. Official transcripts are to be requested from National Student Clearinghouse. Please send official transcripts to <u>admissions@udmercy.edu</u>. Given that transcripts come from a third-party vendor, there will be a small charge to have transcripts issued.
- 3. Official transcript submissions are used to initiate the admission process and allow for timely registration of classes at UDM. Registration for fall 2025 UDM classes begins March 17, 2025 and ends August 24, 2025, with classes beginning August 25, 2025.
- 4. For International Students In addition to the items listed above, send a copy of your proof of English Proficiency, and proof of funding documents for one year of study to UDM at admissions@udmercy.edu. After admission, international Teach Out Students should request the Designated School Official (DSO) at CUWAA to transfer the Form I-20 to UDM's Director of International Admissions, Weihong Sun at: sunwe@udmercy.edu.

V. Limitations

- 1. The terms of the MOU apply to CUWAA students who attend UDM and begin enrollment before September 1, 2025. Teach Out Students will be subject to satisfactory academic progress policies of UDM, upon matriculation at UDM.
- 2. Students must maintain their enrollment for the terms of the MOU to apply. Teach Out Students who go on leave or withdraw from UDM for any reason will need to return to UDM under UDM's own programs and standard admission procedures.
- 3. UDM reserves the right to amend curriculum included in the teach out agreement with CUWAA based upon external accrediting, licensing requirements, or committee recommendations stemming from a scheduled academic program review.

VI. Financial Terms

1. Teach Out Students will be responsible for expenses incurred at UDM as set forth in Exhibit B.

2. UDM is committed to ensuring that the teach-out does not result in unexpected increases to a student's reasonable expectation of total cost of degree. UDM will offer students tuition and/or scholarships and grants that are comparable to the CUWAA packaging guideline and are reflective of student's individual financial needs. UDM may offer CUWAA students additional financial aid opportunities to apply toward regular UDM tuition rates, as long as the student maintains consecutive enrollment, makes satisfactory academic progress, and remains in good standing.

VII. Joint Obligations

- 1. Each party will be responsible for notifying their accrediting body or other entities, as necessary, of the existence and terms of this agreement.
- 2. Both parties acknowledge and agree that this MOU will be given to all CUWAA Teach Out students via email, website or in-person, and a summary of terms made publicly available upon request.

VIII. Term

- The term of this MOU shall commence from the date of the last signature to this MOU
 and continue, subject to Section V: Limitations, through December 31, 2025, to allow
 time for CUWAA students to apply to UDM. Notwithstanding the foregoing, the Teach
 Out Students must matriculate no later than the start of the fall semester 2025 and
 maintain continuous enrollment at UDM in order to remain eligible for the benefits
 outlined in this MOU.
- 2. After the start of the fall semester 2025, requests for admission of CUWAA students to UDM shall be subject to the then current UDM transfer requirements and financial aid benefits for new students transferring to UDM, and any admission decisions are at the sole discretion of UDM.

IX. Miscellaneous

- Nothing contained herein shall imply any partnership, joint venture or agency relationship between the parties and neither party shall have the power to obligate or bind the other in any manner except to the extent herein provided.
- 2. This MOU may be amended only by a written agreement signed by both parties. Notwithstanding the previous statement, UDM reserves the right to amend its programs, policies, procedures. Such changes will be reflected in the UDM Catalog.
- 3. A facsimile or PDF signature shall be deemed an original for purposes of evidencing execution of this MOU. The signatories to this MOU represent and warrant that each

- has the right and authority to execute this MOU in their individual or representative capacity, as applicable.
- 4. This MOU and all of the rights and obligations of the parties and all of the terms and conditions will be construed, interpreted and applied in accordance with and governed by and enforced under the laws of the State of Michigan.
- 5. Any and all notices, designations or other communications provided for herein shall be given in writing by registered or certified mail, return receipt requested, and shall be addressed in the case of the parties to their principal place of business. Email shall also be deemed an acceptable means of notice, provided a notice of receipt is included, and further provided that email is sent to the addresses of the designated individuals of each party who customarily communicate by email.
