- 2. Make arrangements to sign section 3 (Identity and Statement of Educational Purpose) in front of a Concordia Financial Aid Administrator or Center Director. This requires having a valid government issued photo ID with you at the time of signing. IF YOU ARE UNABLE TO APPEAR IN PERSON AT CONCORDIA UNIVERSITY, YOU WILL NEED TO MAKE ARRANGEMENTS TO SIGN THE VERIFICATION WORKSHEET AND A SEPARATE APPENDIX (APPENDIX A) IN FRONT OF A NOTARY.
