If there is a discrepancy between the information on your financial aid award and the information that we receive from the Office of Student Life, appropriate adjustments will be made to your award.*
3. \*All Students are assessed a Student Services fee of \$25/semester and a technology fee for full time students of \$30/semester. Students taking music and art are assessed additional fees. A graduation fee will be assessed the semester you graduate.
4. \*Concordia Aid is all Institutional Aid and Grants awarded from Concordia as per award policies and guarantees, CUAA Academic Scholarship and unmet need.
8. \*Estimated District aid should not be subtracted from your bill until you receive confirmation from the district. Be sure you have completed your application to your home District.
9. \*Congregation estimates are strictly estimates until the University is informed of the exact amount you will receive.
10. \*The Federal Stafford Direct Loan includes a 1.066% fee which will be withheld by the Federal government. The Federal Stafford Master Promissory Note (MPN) and Entrance Counseling must be completed by first time borrowers before the loan(s) can be subtracted from your bill. Returning borrowers do not have to complete a second MPN or Entrance Counseling.

## PAYMENT ARRANGEMENT OPTIONS TO ADDRESS THE ENDING BALANCE DUE

- OPTION 1** *Payment in full* by August 15, 2018 for Fall Semester and January 15, 2019 for Spring Semester
- OPTION 2** *Federal Parent Plus Loan* is available upon request to address your outstanding balance. Download an application from the financial aid website, or apply online at <https://studentloans.gov>. There will be a 4.264% net fee withheld by the Federal government.

- OPTION 3** *Alternative Student Loan.* This is a loan in the student's name with a credit worthy co-signer. See <https://www.cuaa.edu/departments/financialaid/loans.html> for options.
- OPTION 4** *Lutheran Church Extension Fund Joyful Response Program.* Tuition Payments may be made automatically each month from your LCEF Steward Account to Concordia.
